**REGARDING PROJECT “EXTENDING THE SERVICE LIFE OF THE OLKILUOTO 1 AND OLKILUOTO 2 PLANT UNITS AND UPRATING THEIR THERMAL POWER AT THE OLKILUOTO NUCLEAR POWER PLANT IN FINLAND”**

This is a formal reply to the notification in accordance with Article 3 of the Convention on Environmental Impact Assessment in a Transboundary Context (Espoo Convention) by Finnish Environment Institute of 23 January 2024, No. SYKE/2023/1899 regarding the project “Extending the service life of the Olkiluoto 1 and Olkiluoto 2 plant units and uprating their thermal power at the Olkiluoto nuclear power plant in Finland” (hereinafter referred to as “the Project”).

Ministry of Environment of the Republic of Lithuania, acting as an authority responsible for coordination of the transboundary EIA process, has completed the procedures of consulting relevant Lithuanian authorities and the public.

Considering that the distance between the site of the Project and the border of Lithuania is larger than the maximum emergency planning distance defined in the National Plan for Protection of Population in Case of a Nuclear or Radiological Accident (300 km), we do not consider the Project to have likely significant adverse transboundary effects on the environment of Lithuania and do not intend to request transboundary environmental impact assessment procedure under paragraphs 5 to 8 of Article 3 and Articles 4 to 7 of the Espoo Convention. We also have no proposals or comments on the scope of the future EIA report.

However, the EIA programme indicates that the EIA Report will examine potential negative impacts of “beyond design basis” and severe accidents extending up to 1000 km from the nuclear power plant. Therefore we kindly ask to keep us informed about the progress of the Project (including the outcomes of the decision making procedures) and to provide the EIA Report (in English), when it is available.

Naturally, in case the EIA reveals that the Project is likely to cause a significant adverse transboundary impact on the environment of Lithuania, we kindly ask you to contact us again so that we can reassess the situation and the need for participation in the procedures of EIA.
